# **CAFM Advocacy Network Launched!**

This year the family medicine organizations, collectively known as the Council of Academic Family Medicine (CAFM), launched a new advocacy network for family medicine educators who are interested in becoming engaged in the political process. Members of the advocacy network receive a welcome packet and newsletters from government relations staff to help them learn how to become effective advocates, as well as legislative action alerts instructing them on when and how to lobby on behalf of the family medicine community. The newest addition to the CAFM Advocacy Network (CAN) toolbox is a listserve to connect advocates, so they can communicate with other network members about best practices and ongoing advocacy efforts.

**Our goal is to have every department represented in CAN.** Each department's CAN representative will serve as its advocacy leader. The representative's responsibility is to personally respond to calls for legislative action AND to share advocacy opportunities with their fellow faculty members, encouraging them to get engaged and be a voice for family medicine. # **NEW PCMH EVIDENCE REPORTS**

### "Benefits of Implementing the Primary Care Patient Centered Medical Home (PCMH): Cost and Quality Results, 2012"

This new report from the Patient Centered Primary Care Collaborative was described by Marci Nielsen, Executive Director as having a two-fold goal.

"First, it provides a summary of 34 recent peer reviewed and industry reports from PCMH initiatives from the past two years, highlighting cost and quality outcomes data. The results provide substantial empirical support for the PCMH and the health care professionals, health plans, employers and policymakers who are adopting it, as well as the patients and their families receiving this care. Second, the report defines the features of a PCMH and provides data from 23 case studies to demonstrate how each feature of a PCMH contributes to lower costs, improved care and better health outcomes."

## AHRQ Publishes Systematic Review of Literature on PCMH

Based on an exhaustive literature search and using rigorous standards of evidence, the review finds suggestion of benefit for patient and staff experience and preventive services, but lack of evidence to date for beneficial effects on clinical quality or cost (and some reports suggest increased overall cost). It provides some useful suggestions for future research. (Note that Frank deGruy and Mac Baird served on the Technical Expert Panel providing oversight for the review, which was conducted by the Duke Evidence-based Practice Center (EPC)). The Center for Medicare and Medicaid Services (CMS) has revised and posted its "Guidelines for Teaching Physicians, Interns, and Residents" fact sheet (available <u>here</u>). The updated and downloadable document provides information about payments for physician services in teaching settings, as well as general documentation and E/M documentation related to graduate medical education. AAMC successfully secured several GME-related regulatory changes as part of the Affordable Care Act; the updated fact sheet reflects those changes.

## ADFM and Family Medicine Leaders Meet with PCORI

On Thursday, August 2, family medicine leaders met with PCORI leaders Joe Selby, MD, MPH, **Executive Director, Susan** Hildebrandt, Director of Stakeholder Engagement, and Greg Martin, Assistant Director of Stakeholder Engagement. Attending for ADFM/CAFM were Paul James, MD, Tony Kuzel, MD, Hope Wittenberg and Emily Wong. Also in attendance were Andrew Bazemore, MD in his new role as Director, Robert Graham Center, and Debbie Weiner, AAFP government relations.

Paul James and Tony Kuzel described the departments of family medicine and the desire on the part of Family Medicine to perform nationally important research -- research into important questions that clinicians and patients have that bring meaningful change.

According to Dr. Selby, PCORI is thinking about infrastructure in three ways : data and network systems,

methods (analytic research, especially in areas such as engaging patients and dissemination), and training. The training piece has not been fleshed out. As part of the infrastructure discussion, Dr. Selby described the importance to PCORI of leaving a LEGACY and the importance of SUSTAIN-ABILITY. Dr. Selby discussed their need to find platforms for repeatable results – they need quick results, and want to ensure a legacy of good work, especially in time for when PCORI is up for review by Congress. They are looking for models that help patients and clinicians, they want results that can be used Day 1, to help patients.

PCORI is looking for help with "topic generation" -- identifying key questions for research, learning how to engage patients, dissemination, and ways to incentivize physicians to change practice. They want patients to be involved at the outset of all segments - determining what's important to be studied, design of the research and analysis of results, and dissemination and uptake. They have a vision to find out how to get clinicians, patients and systems engaged in producing the science and adopting it into practice. It was emphasized that Departments of Family Medicine have clinical environments where science and a culture of inquiry are already present.

Subsequent to this August 2 meeting, ADFM President, Tom Cambpell, MD and President-elect, Barbara Thompson, MD, met with Ann Bonham, Chief Scientific Officer, AAMC, about AAMC's interest in working with family medicine around PCORI priorities and initiatives. Active conversations are ongoing as we (ADFM) help lead academic family medicine and the Academic Family Medicine Advocacy Committee's efforts to meaningfully engage with PCORI.



#### ADFM Provides Input into the AAFP Foundation's New Education Project

Chris Matson, member of the ADFM Education Transformation Committee, met for a one-day meeting in July with members of other family medicine organizations and the AAFP Foundation, as they discussed the Foundation's potential roll-out of 'Educational Signature' projects. The focus of discussion was What initiatives are the participating FM organizations implementing that assistance with additional resources would have the biggest impact on recruitment of medical students for Family Medicine?'

We look forward to having continued input as the AAFP Foundation pursues these projects.

# **AAMC Chairs' Meeting**

On October 4, ADFM President Tom Campbell and President-Elect Barbara Thompson participated in a "Leaders of Chairs" fly-in meeting in Chicago held by the AAMC. This meeting was meant to provide an opportunity for the AAMC to engage presidents and president-elects of the various groups that represent medical school department chairs in order to begin partnering more effectively with one another. The

AAMC Leadership Team members and government relations staff provided a summary of the Affordable Care Act (ACA) recently upheld by the Supreme Court, the implementation challenges related to the ACA, and the unique implications of health care reform for medical schools and teaching hospitals, and outlined relevant federal policy and advocacy issues on the congressional agenda, including research funding. Part

of the event was devoted to an "open forum" for attendees to share issues and concerns.

While there, Barbara and Tom met with several senior AAMC leaders to discuss issues of common interest and to strengthen ADFM's relationship with AAMC. These conversations will be continued at the upcoming AAMC meeting in San Francisco.
